This issue of AABFJ incorporates studies from a variety of geographic areas. Articles from Indonesia, Australia, India and Iraq are represented in this final issue for 2022.

From Indonesia, Fauziah, Probohudono and Setiwan (2022) analyzed the relationship between board gender diversity and dividend payments. Adhariani (2022) addresses the Ethics of Care in the relationship between enterprise risk management and earnings volatility.

From Australia, there are three studies in this issue, Arjunan (2022) suggests a new method of estimating NPV and IRR based on a company's capital amortization schedule. Bhattacharyya and Kumar (2022) explore the relationship between SMEs' CSR in manufacturing and service industries and SMEs' value and finance access. Finally, incorporating both India and Australia, Dasgupta and Dhochak (2022) have conducted a cross-country study of the progenitors of firms' search behaviour.

Continuing this issues' Indian content, Sedighi and Fereydoon (2022) outline the possible potential of Adaptive Neuro-Fuzzy Inference System (ANFIS), Particle Swarm Optimization (PSO) and Genetic Algorithm (GA) in predicting stock price movements on the Bombay Stock Exchange. Further, Girijan and Ramachandran (2022) explore aspects of double bottom-line commitments (balancing financial and social performance) in the Indian microfinance sector.

From Iraq, Azeez, DongPing and Mahmood (2022) study the relationship between asymmetric cost behaviour and competitive price using external competition as well as internal factors using a cost stickiness model to better understand managers' price decisions.
