Biography

I am a registered midwife with a clinical background that includes postnatal care and breastfeeding / infant feeding support. I have been working at the University of Canberra since 2012, convening and teaching into various Midwifery units. I am the Program Director for the School of Nursing, Midwifery and Public health, ensuring the quality assurance of delivered programs. I co-supervise higher degree research students. I am a practitioner member of the ACT Board of the Nursing and Midwifery Board of Australia.

My Doctoral study examined the impact of the Baby Friendly Health Initiative (BFHI) in the Australian setting and provided recommendations which have informed national public health policy direction. I chair the Australian College of Midwives Advisory Committee for the BFHI in Australia. I am also an International Board-Certified Lactation Consultant and accredited BFHI assessor.

I am currently working with midwifery colleagues across Australia and New Zealand on several different projects: examining Australian and New Zealand women's early parenting experiences during a pandemic; exploring the factors that influence breastfeeding practices at discharge from accredited and non-accredited Australian BFHI hospitals and investigating the support offered to undergraduate midwifery students.

Research Projects, Awards, Grants and Income

My research focus is the health and well-being of women and babies. The infant feeding decisions and practice of women affects not only themselves but also their baby's life and health potential. Breastfeeding according to international recommendations prevents or reduces the risk of a number of short and long-term health conditions. Premature weaning has a negative impact at an individual and societal level as the burden of increasing health care costs for chronic conditions is attributable to infant formula usage.

The Baby Friendly Health Initiative (BFHI) is a global strategy designed to protect, promote and support breastfeeding through health facilities' adoption of "The Ten Steps to Successful Breastfeeding", a set of evidence-based minimum quality standards. My research has shown the BFHI has a positive influence on breastfeeding initiation and duration despite experiencing numerous challenges to uptake and sustainability. It has also revealed the BFHI is highly sensitive to political will. Clear unequivocal leadership in the form of public policy accompanied by adequate human and fiscal resourcing is required to incentivise the entire health system and create changes in clinical practice and the maternity care

workplace.

Current Projects

- Chief Investigator: The diversity of clinical education support in Australia: mapping the midwifery landscape. This UC project will create a contemporary national profile of the support provided to students by Australian midwifery programs and provide UC an opportunity to benchmark against the nation. Results will be presented at the inaugural Trans-Tasman Midwifery Education Conference in September 2018.
- Co-investigator: "I am just a different creature on this world." This School of Nursing and Midwifery unfunded project is exploring international nursing students' experiences of assimilating into the local socio-economic environment; meeting the requirements of tertiary study/university life and transitioning into Australian clinical practice settings. Results will be published in a peer reviewed journal
- Co-investigator: Evaluating the development of cultural competence in undergraduate health students. This Faculty of Health unfunded pilot project is exploring the extent to which short-term international study abroad programs enable learning about a country and its people as well as increasing cultural awareness. Results will be published in a peer reviewed journal and used to inform a larger project.
- Co-investigator: Promoting Workplace Health. This UC Discipline of Midwifery/Synergy Nursing & Midwifery Research Centre/ACT Health funded practice development project aims to enhance the workplace health and culture in one ward area of the Centenary Hospital for Women and Children.
- Co-investigator: This Trans-Tasman Consortium project is re-validating the Australian Midwifery Standards Assessment (AMSA) Tool using the newly released Nursing & Midwifery Board of Australia (NMBA) Midwifery Standards for Practice. The AMSA Tool is a vital element of UC's Midwifery programs. It is used as a comprehensive summative and formative form of assessment in determining the competency of student midwives' clinical practice and work readiness.
