SCHOLARLY CONTRIBUTIONS

Xiaodong Gong as an Australian economist has contributed significantly to the understanding of individuals/households' behaviour in the labour market, juridical behaviour, consumer behaviour, and of the behaviour of other societal types (notably gamblers). His work has contributed to better identification of key policy parameters by applying advanced and appropriate econometric techniques in modelling. He has published in 25 international academic journals of economics and public policy. He is in the top 12.5 percent of economists in the REPEC rankings of citations, the mostly widely used international citation instrument.

He has made important academic and policy contributions in the following areas: individual and household behaviour in developing countries and in Australia, particularly the impact of childcare subsidies and welfare reforms on Female Labour Force Participation in Australia; household consumption; the effect of tax policy on the take-up of private health insurance, and; individual socio-economic behaviour including gambling. Xiaodong's achievements include high quality academic publications and influence on policy and policy thinking in Australia.

He has contributed significantly to methodology innovation and application to policy relevant socio-economic issues, enabling more thorough and appropriate analysis and evaluation of policy.

DENTIFIABLE BENEFITS OUTSIDE OF ACADEMIA

a) Xiaodong's work has been instrumental to policy thinking around childcare subsidies and women's labour supply in Australia, and forms a cornerstone of current childcare subsidy policy in Australia. His series of work on childcare have been quoted in one of the Senate hearings on Childcare in 2011, by the OECD report on Australia's childcare policy, and by the Productivity Commission. The Productivity Commission (2015) in its inquiry into childcare in Australia and recommendations for a new policy framework (implemented by the government in2017) relied heavily upon a series of Xiaodong's work on childcare.

- b) His work on the impact of judicial background on judges' behaviour (Freyens and Gong, 2017) has been interested by the policymakers including Productivity Commission, Department of Employment, and FairWork Australia. They were invited to present this piece of work at Productivity Commission and Department of Employment.
- c) The quality of Xiaodong's research means he is often approached for advice by many government departments and agencies, including the Departments of Prime Minister and Cabinet, Education, Employment, Social Services, and Fair work Australia, for state governments of NSW, Victoria, and the ACT, and the Productivity Commission.
- d) His work has also been interested by the Media, e.g., both Gong (2011) and Breunig et al(2010) were reported by the major media outlets including SMH, the Australian, and the Financial Review. In 2020, he has been interviewed by SBS two times on Australia's childcare and wage allowance policy duringCOVID-
